After you review this material, please sign the separately attached signature page and return to the dispensary.

Cardholders must sign this form acknowledging they have received this information at least once per year or whenever major changes to this pamphlet occur.

The dispensary must retain your signature for a period of thirty-six (36) months.

Medical cannabis cardholders in Kentucky should consider:

- Product formats and supply limits
- Prohibited products and uses
- Potential prescription drug and other substance interactions
- Proper transportation and storage
- Requirements for purchase (including valid driver's license to be presented with a medical cannabis card)

- Child and pet safety

Program overview

On March 31, 2023, Gov. Beshear signed Senate Bill 47 into law and created the Kentucky Medical Cannabis Program. The Medical Cannabis program allows patients with qualifying medical conditions to register with the Office of Medical Cannabis to purchase and consume medical cannabis.

This pamphlet serves to provide evidence based educational materials on the risks, dangers, and possible side effects of medical cannabis, as well as to inform patients on how to report potential negative side effects of medical cannabis.

Methods of consumption

Medical cannabis may be used in any of the following forms:

Prohibited methods of consumption

- Combustion of cannabis, such as smoking
- •For patients under 21 years old, consumption by vaporizing is not allowed

Dosage information

The amount of THC and CBD, directions for use, and number of servings can be found on the medical cannabis packaging. Dosing varies by product. To avoid potential side effects, it is recommended to start at a low dose and increase the dosage slowly over time.

Proper storage

Medical cannabis products should always be stored in their original containers and kept out of the sight and reach of children.

Effects and impairment

Cannabis can cause effects that may include:



Altered senses (for example, seeing brighter colors)



Altered sense of time



Changes in mood



Impaired body movement



Difficulty with thinking and problemsolving



Impaired memory



Hallucinations or delusions (when taken in high doses)



Psychosis (this risk is highest with regular use of high-potency cannabis)

Do not drive, operate machinery, or do work that could harm people while using medical cannabis.

Adverse effects reporting

If you are experiencing a life-threatening emergency, call 911 or go to an emergency room immediately. If a child or someone you know accidently consumes medical cannabis, call (800) 222-1222 for the Kentucky Poison Control Center.

If you are having a non-life-threatening adverse effect, speak to your healthcare provider and report the incident at kymedcan.ky.gov or call (502) 564-7907. When reporting an adverse effect, please complete the online form and provide a photo, receipt, or image of the product and label.

For accidental consumption by pets, contact the ASPCA Poison Control Hotline at (888) 426-4435.

Talk with your doctor about medical interactions

Discuss all your medical conditions and other medications you take with your health care provider prior to starting medical cannabis.

The following conditions may have negative interactions with cannabis use:

- Cardiovascular disease
- Arrhythmias
- Poorly controlled hypertension
- Severe heart failure
- History of psychotic disorder
- Pregnancy or nursing

How to obtain treatment for medical cannabis abuse

Designated caregivers

If you need assistance with medical cannabis care, the program allows patients to designate a caregiver to assist with buying, transporting, storing, and administering medical cannabis.

Designated caregivers must apply for a registry ID card through the patient and caregiver registry portal at kymedcan.ky.gov.
