


# Quick Reference Guide for Kentucky Raw Plant Material Labeling

This quick reference guide provides a summary of how to properly label medical cannabis in the form of **raw plant material** with a sample label for example.

## Raw plant material sample labeling

Licensed cultivators, processors, and producers may reference the sample label for information and identifiers required for raw plant material.

## Proper use of QR codes



Sample QR Code

### Information allowed to be presented via QR code:

- Name and license # of the cannabis business that cultivated the medical cannabis
- Name and license # of the cannabis business that packaged the medical cannabis
- Date the medical cannabis was packaged

### QR code requirements:

- “Specific Product Information” must be written directly above or below the QR code
- Must be large enough to be smart-phone readable
