## How To Guide for Kentucky Scale Certification



This quick reference guide provides guidance for licensed cultivators and processors regarding the rules and restrictions as established by 915 KAR 1:030 and 915 KAR 1:040 for the operation of equipment.

## 915 KAR 1:030 Cultivator and 915 KAR 1:040 Processor

**915 KAR 1:030, Section 10** and **915 KAR 1:040, Section 10** mandate that medical cannabis businesses <u>shall</u> have a written process to maintain the operation of equipment that comes in contact with medical cannabis. Part of this written process requires that the cultivator or processor shall:

- 1) Routinely calibrate, check, and inspect automatic, mechanical, or electronic equipment as well as any scales, balances, or other measurement devices used in the operations to ensure accuracy; and
- 2) Maintain an accurate log recording the:
  - a. Maintenance of equipment;
  - b. Cleaning of equipment; and
  - c. Calibration of equipment.

**Contacting the Department of Agriculture:** Kentucky law requires scales used in commercial transactions to be inspected and certified. To initiate this process, please review the following information:

- 1) Contact the Department of Agriculture Weights and Measures Program directly via telephone at (502) 573-0282;
- 2) Schedule an appointment for inspection, calibration, and certification by a listed service technician within your geographic area or region; and
- 3) Prepare to pay any applicable fees for inspection and certification;

**Certification and Compliance:** Once calibrated, the Department of Agriculture will verify the scale's accuracy and issue an annual certification decal to be placed upon each instrument; each certification will remain valid for a length of time determined by Department of Agriculture guidelines.

## Cannabis businesses remain compliant by:

- 1) Maintaining all certification and maintenance records and ensure they are readily accessible to be provided upon request by any Office of Medical Cannabis investigator or other qualified state personnel conducting official duties;
- 2) Re-calibrating as required by Department of Agriculture regulations and guidelines; and
- 3) Conducting routine maintenance to prevent inaccuracies due to cleanliness, mechanical wear, or other environmental factors.

**Conclusion:** Calibrating scales through the Department of Agriculture is an essential step in maintaining compliance within the medical cannabis program. Regular inspection, calibration, certification, and adequate documentation will meet state regulatory requirements. Stay informed about updates to calibration regulations and ensure your business remains compliant to avoid penalties and/or sanctions.
