

How To Guide for Kentucky Edible Labeling

This quick reference guide for licensed medical cannabis businesses in Kentucky provides a summary of how to properly label medical cannabis in the form of **edibles** with a sample illustration for example.

Edible sample labeling

Licensed processors and producers may reference the sample label illustrated below which includes the information and content identifiers required for medical cannabis products in the form of edibles.

Sample QR Code
(Example Only)

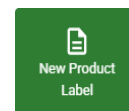
Information allowed to be presented via QR code:

- Name and license # of the cannabis business that cultivated the medical cannabis
- Name and license # of the cannabis business that packaged the medical cannabis
- Date the medical cannabis was packaged

QR code requirements:

- Must contain “Specific Product Information” written directly above or below the QR code
- Must be large enough to be scanned by a smart-phone
