## **ORDINANCE NO. 18:2024**

AN ORDINANCE OF THE CITY OF MOREHEAD, KENTUCKY AMENDING THE OFFICIAL ZONING CODE, TITLE XV: LAND USAGE, CHAPTER 154 ZONING CODE OF THE CODE OF ORDINANCES OF THE CITY OF MOREHEAD, KENTUCKY TO ALLOW AND REGULATE THE OPERATION OF MEDICAL CANNABIS FACILITIES IN THE CITY AS PERMITTED BY KRS 218B.130.

WHEREAS, on the 5<sup>th</sup> day of June 2024, the Morehead-Rowan County-Lakeview Heights Joint Planning Commission did hold a public hearing on application by the City of Morehead through its City Planner and Building Inspector requesting a zoning code text amendment to allow and regulate medical cannabis operations (cultivation, processing, producing, and the dispensing of medical cannabis) in the City of Morehead;

**WHEREAS**, upon said application, the Morehead-Rowan County-Lakeview Heights Joint Planning Commission did make written Findings of Fact and Recommendations in support of the requested amendment, a copy of said Findings and Recommendations is attached hereto; and

WHEREAS, the Board of City Council of the City Morehead, Kentucky concurs with the attached Recommendations of the Morehead-Rowan County-Lakeview Heights Joint Planning Commission.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of City Council of the City of Morehead, Kentucky:

## **SECTION ONE**

Title XV: Land Usage, Chapter 154, Zoning Code, Section 154.148 Permitted Uses of the Code of Ordinances of the City of Morehead, Kentucky shall be amended to reflect the operation of medical cannabis facilities as follows:

## § 154.148 PERMITTED USES.

- (A) General provisions. Table 148-1: Permitted Uses lists the uses allowed within the designated zoning districts.
- (B) Permitted uses. A "P" in a cell indicates that a use is allowed by-right in the respective zoning district. Permitted uses are subject to all other applicable regulations of this code.
- (C) Permitted uses with standards. A "PS" in a cell indicates that a use category is allowed by-right in the respective zoning district if it meets the additional standards set

forth in the numerically referenced sections. Permitted uses with standards are subject to all other applicable regulations of this code.

- (D) Conditional uses. A "C" in a cell indicates that a use may be permitted if approved though conditional use permit review (see § 154.126: Conditional Use Permit). Conditional uses may be subject to use specific standards as identified in the last column of Table 148-1: Permitted Uses. Conditional uses are subject to all other applicable regulations of this code.
- (E) Prohibited uses. A blank and/or shaded cell indicates a use that is prohibited in the respective zoning district.
- (F) Numerical reference. The numbers contained in the "Additional Standards" column are references to additional standards and requirements that apply to the use type listed. Standards referenced in the "Additional Standards" column apply in all zoning districts unless otherwise expressly stated.
- (G) Permitted use table.
