

ORDINANCE NO. 411.0

**AN ORDINANCE RELATING TO THE ALLOWANCE OF MEDICAL CANNABIS
BUSINESS OPERATIONS IN THE COUNTY OF BOYLE,
COMMONWEALTH OF KENTUCKY**

WHEREAS, on April 15, 2024, the Kentucky General Assembly adopted House Bill 829, signed into law by the Governor on April 17, 2024 amending KRS Chapter 218B, the Kentucky Medical Cannabis Chapter;

WHEREAS, KRS §§218B.090 and 218B.130 authorize local governments to prohibit or allow cannabis business operations within their territory through the passage of an ordinance;

WHEREAS, it is necessary and appropriate to allow Medical Cannabis Business Operations in the County of Boyle, and in the best interest of the health, safety, and welfare of the County of Boyle’s residents and members of the public who visit, travel, or conduct business in the County of Boyle to allow medical cannabis business operations within the boundaries of the County of Boyle;

WHEREAS, said Ordinance will help to facilitate a novel, growth industry, and it thus promotes the Economic Development Goal: “To provide a growing, diverse economic base for the community which allows for full employment of citizens”; and

WHEREAS, the County of Boyle wishes to utilize the authority granted to it by KRS §§218B.090 and 218B.130 to allow medical cannabis business operations within the boundaries of the County of Boyle,

The definitions within KRS §218B.010 are hereby adopted as if set out herein and as relevant to this Ordinance.

SECTION 2. Medical Cannabis Business Operations Allowed:

Medical cannabis business operations shall be allowed to operate within the boundaries of Boyle County and shall be subject to the regulation of the Danville-Boyle County Planning and Zoning Commission and Joint Zoning Ordinance 920.7 for Boyle County, Kentucky.

SECTION 3. Effective date:

This Ordinance shall be effective upon its enactment and publication by the County of Boyle and shall further comply with KRS §§218B.090 and 218B.130.

SECTION 4. The entire Fiscal Court being present, on motion of

JASON CULLEN, seconded by TOM V. ELLIS, 6 voting in favor,

0 voting against, 0 abstaining, this Ordinance was given first reading and passed on August 27, 2024.

SECTION 5. The entire Fiscal Court being present, on motion of

0 voting against, 0 abstaining, 1 being absent, this Ordinance was given second reading and passed

on September 10, 2024.
