Ordinance No. 5, Series 2024

AN ORDINANCE RELATING TO THE PROHIBITION OF CANNABIS BUSINESS OPERATIONS IN THE CITY OF HOLLOW CREEK

WHEREAS, on April 15, 2024, the Kentucky General Assembly adopted House Bill 829, signed into law by the Governor on April 17, 2024 amending KRS Chp. 218B, the Kentucky Medical Cannabis chapter; and

WHEREAS, KRS §§218B.090 and 218B.130 authorize local governments to prohibit cannabis business operations within their territory through the passage of an ordinance; and

WHEREAS, it is necessary and appropriate, and in the best interest of the health, safety, and welfare of the CITY OF HOLLOW CREEK, KY's residents and members of the public who visit, travel, or conduct business in the CITY OF HOLLOW CREEK, KY to prohibit all cannabis business within the boundaries of HOLLOW CREEK; and

WHEREAS, the CITY OF HOLLOW CREEK, KY wishes to utilize the authority granted to it by KRS §§218B.090 and 218B.130 to prohibit cannabis business operations within Hollow Creek's city limits and jurisdiction.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Commissioners of Hollow Creek, Commonwealth of Kentucky:

Section 1

Definitions

The definitions within KRS §218B.010 are hereby adopted as if set out herein and as relevant to this ordinance.

Section 2

Cannabis Businesses Prohibited

All cannabis businesses are hereby prohibited from operating within Hollow Creek city limits and jurisdiction. Further, the city opts-out of any Kentucky law automatically allowing "cannabis business operations" in the city limits and jurisdiction of Hollow Creek. **

Section 3 -- Effective Date

This ordinance shall become effective upon its passage and publication required by Kentucky Law.
