### ORDINANCE NO. #74

### AN ORDINANCE RELATING TO THE PROHIBITION OF CANNABIS BUSINESS OPERATIONS IN THE COUNTY OF GREENUP

**WHEREAS**, on April 15, 2024, the Kentucky General Assembly adopted House Bill 829, signed into law by the Governor on April 17, 2024, amending KRS Chapter 218B, the Kentucky Medical Cannabis chapter; and

WHEREAS, KRS §§218B.090 and 218B.130 authorize local governments to prohibit cannabis business operations within their territory through the passage of an ordinance; and

WHEREAS, it is necessary and appropriate, and in the best interest of the health, safety, and welfare of the County of Greenup's residents and members of the public who visit, travel, or conduct business in the County of Greenup to prohibit all cannabis business within the boundaries of the County of Greenup; with the exception of any incorporated city; being Bellefonte, Flatwoods, Greenup, Raceland, Russell, South Shore, Worthington and Wurtland all of Greenup County which approves the sale of Kentucky Medical Cannabis, and Medical Cannabis Business where properly permitted.

WHEREAS, the County of Greenup wishes to utilize the authority granted to it by KRS §§218B.090 and 218B.130 to prohibit cannabis business operations within the County of Greenup other than the exception provided to the incorporated cities outlined in the above paragraph.

**NOW, THEREFORE, BE IT ORDAINED** by the Fiscal Court of County of Greenup, Commonwealth of Kentucky:

#### Section 1

#### **Definitions**

The definitions within KRS §218B.010 are hereby adopted as if set out herein and as relevant to this ordinance.

#### Section 2

#### **Cannabis Businesses Prohibited**

All cannabis businesses are hereby prohibited from operating within Greenup County limits unless properly permitted by the laws of an incorporated city within the boundaries of Greenup County.
