Quick Reference Guide for Kentucky Minor Qualified Patients



Application and purchasing process

Visit two practitioners

A minor qualified patient applicant must visit a medical cannabis practitioner in-person to **obtain an initial written certification**. Minors must also receive a diagnosis of a qualifying medical condition from a second practitioner.

Submit minor patient application

The minor qualified patient must apply online through the patient and caregiver registry portal and provide:

- Documentation of a diagnosis of a qualifying medical condition accompanied by a written certification
- Signed and notarized signature form with responsibility statement signed by parent or legal guardian
- Caregiver information
- Application fee

The Cabinet will approve or deny the minor patient's application within thirty (30) days of receiving a completed application.

Submit caregiver application

Once the minor patient's application has been approved, the designated caregiver must also **apply** and provide:

- Patient registry ID number
- Signed and notarized signature form with responsibility statement
- Application fee

Receive registry ID cards

The Cabinet will approve or deny the caregiver's application within 30 days of receiving a completed application. If the application is approved, the caregiver will receive a **digital registry ID card**, and the patient's ID card will become valid.

Caregiver may purchase medical cannabis

The designated caregiver must **purchase medical cannabis for the qualified minor patient** at a licensed dispensary and control the patient's supply and dosage.

Additional information

Qualifications for minor applicants

- Resident of Kentucky
- Under the age of eighteen (18) years old
- Received a diagnosis of a qualifying medical condition from a practitioner and obtained a written certification from a medical cannabis practitioner
- Must not have any disqualifying felony convictions
- Custodial parent or legal guardian agrees to minor's use of medical cannabis and will serve as the minor's designated caregiver

Qualifications for caregivers of minors

 Custodian parent or legal guardian with responsibility for health care decisions for the minor qualified patient and otherwise eligible to serve as a designated caregiver

Qualifying medical conditions

- Any type or form of cancer regardless of stage
- > Chronic, severe, intractable, or debilitating pain
- Epilepsy or other intractable seizure disorder
- Multiple sclerosis, muscle spasms, or spasticity
- Chronic nausea or cyclical vomiting syndrome
- Post-traumatic stress disorder

30-day supply limit by product form¹

112 grams of raw plant material;

28 grams of concentrate²; or

3,900 milligrams of THC infused medical cannabis products such as edibles

Initial and renewal registry ID card fees for minor qualified patients

Cardholder type	Annual fee
Initial application fee	\$25
Annual renewal fee	\$25

¹ Medical cannabis practitioners may recommend exceptions to established supply limits under certain conditions.

² Caregivers of minors may not purchase or administer products intended for consumption by vaporization.
