***RE: Reissued Notice of Fine***

Licensee Armory Kentucky LLC:

On July 11, 2025, Armory Kentucky LLC (CULT009033) received approval from the Office of Medical Cannabis (OMC) to begin medical cannabis business operations with the following express condition:

***Deficiency 1 – Harvested plants/medicinal cannabis material shall not be transferred from building B to building C prior to the completion and approval of the specified walkway.***

On September 2, 2025, OMC informed your representative, Bradley Clark, that investigators would be on site on September 4, 2025 at 10:30am CST to inspect the breezeway/walkway connecting building B to building C. On September 4, 2025, your representative self-reported to OMC that Armory Kentucky LLC had transferred 679 plants into building C on August 21, 2025, which was prior to receiving approval from OMC as required by the express terms of its conditional approval (see above).

On September 24, 2025, OMC issued its original Notice of Fine arising from the above-described conduct. The September 24, 2025 Notice of Fine is rescinded and replaced by this Notice of Fine.

In accordance with 915 KAR 1:020 Section 12(1), OMC issues the following enforcement actions to licensee Armory Kentucky LLC:

- A fine of sixty-seven thousand nine hundred dollars (\$67,900.00), which equates to a fine of \$100 per plant improperly transferred to “building C” prior to receiving OMC approval; and

- Suspension for sixty (60) calendar days from the date of the original notice (September 24, 2025), which was conditionally deferred for sixty (60) calendar days from the date of OMC's original notice and has now been completed.

Per KRS 218B.100(3), the OMC shall provide notice of suspension, revocation, fine, or other penalty, as well as the required notice of the right to request an administrative hearing, by mailing, via certified mail, the same in writing to the cannabis business at the address on the license. **The cannabis business may, within thirty (30) days after the date of the mailing of the cabinet's notice, file a written request for an administrative hearing regarding the suspension, revocation, fine, or other penalty. The hearing shall be conducted in compliance with the requirements of KRS Chapter 13B.**
